Information Collected and Stored Automatically

If you do nothing during your visit but browse through the Web Site or read our Web pages, we will gather and store certain information about your visit automatically. This information does not identify you personally. We may automatically collect and store only the following information about your visit:

- The Internet domain and IP address from which you access our Web Site;
- The type of browser and operating system used to access our Web Site;
- The date and time you access our Web Site;
- The pages you visit; and
- If you linked to our Web Site from another web site.

We use this information to help us make our Web Site more useful to visitors, to learn about the number of visitors to our Web Site, and to determine the types of technology our visitors use. We do not track or record information about individuals and their visits.

If You Send Us Personal Information

If you choose to provide us with personal information, such as in an e-mail to the Administrator or by filling out a form with your personal information and submitting it to us through our Web Site, we use that information to respond to your message and to help us get you the information you have requested. We only share the information you give us with another agency if your inquiry relates to that agency, or as otherwise required by law. Moreover, we do not create individual profiles with the information you provide or to give it to any private organizations. The Monmouth County Park System does not collect information for commercial marketing.

Personal Information and Choice

You may choose whether to provide personal information on-line. "Personal information" is information about a real person that is readily identifiable to that specific individual. Personal information includes such things as an individual's name, address, and telephone number. A domain name or Internet protocol address is not considered personal information.

We collect no personal information about you unless you voluntarily give it to us by sending us an e-mail or by providing personal information when using an on-line form. Your choice not to participate in these activities will not impair your ability to browse the Monmouth County Park System's Web Site and read any information provided on the Web Site.

Privacy Warning

E-mail is not a secure medium. Personal information sent via the Internet can be intercepted. You may, therefore, wish to reconsider the advisability of sending messages that contain sensitive or personal information to this Internet address.

The Monmouth County Park System does not plan to voluntarily divulge information collected or information disclosed, but it may be required to do so pursuant to a request under the State Right to Know law, the common law concerning the Right to Know, other State or Federal law, or pursuant to a court order.
